ITEM NO: 1.i. Review and approve the Community Development Block Grant
SUBJECT: (CDBG) agreement for fiscal year 2019-2020

DISCUSSION: The County of Fresno's Department of Public Works and Planning - Community Development Division is requesting approval of the 2019-2020 agreement for CDBG grant funding from the City of Selma.

The project application for the 2019-2020 funding cycle is the:

Neighborhood Sidewalk Connectivity Project

The proposed activity includes concrete improvements in the public right of way to provide continuous curb, gutter, and sidewalk and drive approaches where missing in the following neighborhoods:

- Area bound by Thompson to the west, McCall to the east, Nebraska to the north, and Valley View to the south.
- Area bound by McCall to the west, Orange to the east, Floral to the north, and Rose to the south.

The Engineer's estimate for this project is \$275,000.

A G R E E M E N T

THIS AGREEMENT ("Agreement") is made this _____ day of _____, 2019 ("Effective Date"), by and between the COUNTY OF FRESNO, a political subdivision of the State of California, ("County"), and the CITY OF SELMA, ("City").

WITNESSETH

WHEREAS, the County has been designated as the sponsoring agency to administer and implement the Community Development Block Grant ("CDBG") Program activities for the County, and its participating cities, in accordance with the provisions of Title I of the Housing and Community Development Act of 1974, as amended, and the laws of the State of California; and

WHEREAS, CDBG funding has been made available to the County for housing and community development activities; and

WHEREAS, the City has submitted the Selma Sidewalk Connectivity Project No. 19651 ("Project") for CDBG funding; and

WHEREAS, the City has estimated that the total cost of the Project is \$275,000, and the City has committed local funds to the Project in the amount of \$45,802, and is in need of \$229,198 in CDBG funding to complete the Project; and

WHEREAS, the County can provide \$229,198 in CDBG funds needed for the Project from the City's 2019-2020 CDBG allocation (\$218,555) and from the City's remaining balance of CDBG funds (\$10,643); and

WHEREAS, the Project is consistent with the objectives of the Fresno County Consolidated Plan, including the annual Action Plan.

NOW THEREFORE, in consideration of their mutual promises as hereinafter set forth, the City and County agree as follows:

I. PROJECT DESCRIPTION, LOCATION AND BUDGET

A. The Project consists of the construction or replacement of curb, gutter, sidewalk, drive approaches, and curb ramps where missing, damaged, or not meeting current Americans with Disabilities Act (ADA) requirements to create a safe continuous pedestrian

1 travelling surface. Existing signs, pavement markings, curb, gutter, sidewalk, drive approaches,
2 street lights, storm drain inlets, and landscape may be modified, replaced, and/or relocated to
3 accommodate the proposed improvements. The Project is located at various locations within the
4 area generally bounded by Floral, Dockery, Saginaw, and Highland Avenues. All work is within
5 City of Selma right-of-way. The improvements will eliminate many pedestrian barriers and provide
6 a safe and continuous travelling surface for residents.

7 B. The Project site is within the City's existing easements or public rights-of-
8 way.

9 C. The work to be funded with CDBG funds is as follows:

10 1. Obtain all necessary permits.

11 2. Perform all necessary design engineering including, but not limited
12 to, surveying; testing; preparation of plans, specifications, and cost estimates; bid documents and
13 a cost or price analysis; review of bids and recommendation for award.

14 3. Prepare and advertise Project bid notices and award construction
15 contracts including, but not limited to, the printing of bid documents; publishing of notices; and
16 preparation of bid summary.

17 4. Perform all construction engineering including, but not limited to,
18 shop drawing review and approval; contract change order preparation; surveying; staking;
19 inspection; soil testing; materials testing; preparation of "as-built" drawings; labor compliance; and
20 contract administration.

21 5. Provide related eligible improvements.

22 D. The Project budget is estimated by the City as follows:

26 E. Notwithstanding the City's estimates described in the above Project budget,
27 payments for the Project from CDBG funds will be limited to the City's actual costs expended by
28 the City, and shall not exceed the total amount of \$229,198.

1 F. The proposed funding for the Project will be provided from the following
2 sources:

5 G. Prior to any changes that may occur which would modify the scope of the
6 Project, the City shall submit a written request to the County. The City shall send its written request
7 to:

14 If the Director of the County Department of Public Works and Planning (“Director”) determines the
15 modified Project is still eligible under the Federal CDBG regulations, the Director is authorized to
16 permit such modifications. The County shall specify in a letter to the City that such modifications
17 to the scope of the Project are authorized, and if the City may proceed.

18 II. OBLIGATIONS OF THE COUNTY

19 A. The County shall reimburse the City up to, but not more than, \$229,198 of
20 CDBG funds to the City for the Project for the City’s performance of its obligations under this
21 Agreement. All funds shall be paid to the City in accordance with Section V-A of this Agreement.

22 B. The County shall review, within thirty (30) calendar days of receipt from the
23 City, the engineer selection process description and summary of the analysis, as prepared by the
24 City, to verify that a competitive process was conducted in accordance with U.S. Department of
25 Housing and Urban Development (HUD) procurement standards. If such conditions have been
26 met, the County shall specify in a letter to the City that these conditions have been met and that
27 the engineering contract can be awarded.

28 C. The County shall review, within thirty (30) calendar days of receipt from the
City, the design plans and specifications for the Project, as prepared by the City, for compliance
with Federal regulations, and the total Project cost estimate to ensure sufficient funds are available
to complete the Project. If such conditions have been met, the County shall specify in a letter to

1 the City that these conditions have been met and that the Project can be advertised.

2 D. The County shall also review, within twenty one (21) calendar days of receipt
3 from the City, the name of the low bidder and cost or price analysis of the low bid proposal prepared
4 by the City, to determine whether the contractor will be reasonably compensated in accordance
5 with Federal requirements, and to verify the contractor is bonded and has not been disbarred or
6 suspended from participating in Federal projects. If such conditions have been met, the County
7 shall specify in a letter to the City that these conditions have been met and that the contract can
8 be awarded.

9 E. The County shall attend the pre-construction meeting between the City and
10 the contractor to discuss labor compliance requirements for the Project, Project monitoring, and to
11 inform the City and contractor that the County will conduct field reviews to ensure labor compliance
12 and other conditions of the construction contract are being met.

13 F. The County shall conduct periodic inspections of the Project, as may be
14 required in the determination of the County, to ensure that the intended use and group of
15 beneficiaries of the Project have not changed. Upon completion of the Project, but prior to the
16 City's acceptance of the Project, the County shall conduct a final inspection of the Project. If such
17 conditions have been met, the County shall specify in a letter to the City that the conditions of this
18 Section have been met.

19 III. OBLIGATIONS OF THE CITY

20 A. The City shall provide any and all sums of money in excess of \$229,198 that
21 may be necessary to complete the Project. For the purposes of awarding the construction of the
22 Project within the Agreement amount, the bid documents should include any proposed additive or
23 deduct alternatives.

24 B. The City shall perform, or cause to be performed, all engineering work
25 required for the Project.

26 C. In selecting an engineer to perform any engineering work required for the
27 Project, the City shall go through a competitive process in accordance with Fresno County
28 Ordinance Code 4.10 and HUD procurement standards. Prior to selection of the engineer, the City

1 shall prepare a written description of the process, perform a cost or price analysis, and submit the
2 process description and summary of the analysis to the County Community Development Division
3 for review. The City shall obtain a letter from the County specifying that the conditions of this
4 Section have been met.

5 D. The City shall specify in agreements with its consultants that all engineering
6 work funded with CDBG funds shall become the property of the City upon payment by the City for
7 the cost of such engineering work.

8 E. The City shall furnish evidence, prior to the County's authorization to
9 advertise for bids, that it has free and clear title to all parcels of land on which Project improvements
10 will be located, with any liens or encumbrances noted, and/or that it has obtained or can obtain all
11 necessary easements, rights-of-way, licenses, permits, and State and local approvals required for
12 the completion of the Project.

13 F. Upon completion of the design engineering, the City shall submit the plans
14 and specifications to the County Community Development Division. The County will ensure
15 Federal CDBG requirements have been adhered to, and review cost estimates to ensure sufficient
16 funds are available. The City shall obtain a letter from the County specifying these conditions have
17 been met, and that the City is approved to advertise for bids to construct the Project.

18 G. The City shall advertise for bids, and shall award the construction contract
19 to the lowest responsible bidder. At least ten (10) calendar days prior to the bid opening, the City
20 shall notify the County of the date, time, and location of the bid opening.

21 H. Within seven (7) calendar days following the bid opening, the City shall
22 furnish the County Community Development Division with the name of the low bidder and cost or
23 price analysis of the low bid proposal prepared by the City, so that the County can verify with the
24 Labor Relations and Equal Opportunity Division of the HUD Area Office that the low bidder is
25 bonded and has not been debarred or suspended from participating in Federal projects, and that
26 the contractor will be reasonably compensated in accordance with Federal requirements. The City
27 shall obtain a letter from the County specifying these conditions have been met, and that the City
28 is approved to award the Project for construction.

1 I. The City shall conduct a pre-construction meeting with the contractor, and
2 shall notify the County Community Development Division at least ten (10) calendar days prior to
3 the meeting, so a representative of the County can attend to discuss CDBG labor compliance
4 requirements for the Project.

5 J. Prior to the construction start date, the City shall give written notice thereof
6 to the County Community Development Division.

7 K. All proposed construction contract change orders shall not proceed until
8 prior written approval has been given by the County. Request for approval of a change order(s)
9 shall include a narrative description of the work, a cost or price analysis in accordance with HUD
10 requirements, a map depicting the location of the work addressed with the requested change order,
11 and a written certification from the City that the approval of the change order is consistent with the
12 final construction cost estimate approved by the County. In addition, the City shall certify that the
13 change order is within the scope of the Project and is necessary to complete the Project.

14 L. The City shall send its written description of the engineer selection process,
15 cost or price analyses, design plans, specifications, name of low bidder and low bid proposal,
16 public notices, and all written correspondence to:

24 M. The City shall comply with the conditions and notes identified in
25 Environmental Review No. 7640 (the "Review"). A copy of the Review will be provided to the City.

26 N. Upon completion of the Project, the City shall notify the County Community
27 Development Division, so a representative of the Division can perform an inspection of the Project
28 to confirm that it was completed in accordance with the scope of work approved and authorized
pursuant to this executed Agreement.

O. Upon approval of Project completion by the County, the City shall provide
the County Community Development Division with a resolution of acceptance, or similar

1 documentation, demonstrating that the Project was completed in accordance with the scope of
2 work approved and authorized pursuant to this executed Agreement, and any approved
3 subsequent amendments thereto and/or change orders, and that the City has accepted the Project.
4 Prior to the final request for payment, the City shall also provide the County with a copy of the
5 recorded Notice of Completion (NOC), a written summary of all Project work completed with CDBG
6 and other funds, and documentation to demonstrate compliance with Section 3 of the Housing and
7 Urban Development Act of 1968, as amended.

8 P. During the contract period, the City shall complete and submit annually each
9 June 1, and upon completion of the Project, a Project Outcome Measurement Report (POM) form,
10 a copy of which is attached hereto as Exhibit 1, and incorporated herein by reference. The POM
11 shall contain the following information for the County's Federal reporting purposes to the U.S.
12 Department of Housing and Urban Development (HUD):

- 13 1. Total number of households/persons assisted.
- 14 2. Number of total households/persons assisted that:
 - 15 a. Now have new access to this type of public facility or
16 infrastructure improvement.
 - 17 b. Now have improved access to this type of public facility or
18 infrastructure improvement.
 - 19 c. Now are served by a public facility or infrastructure that is no
20 longer substandard.

21 Q. The City shall be responsible for maintenance of the Project after
22 construction is completed, and shall perform such maintenance from non-CDBG resources.

23 R. The City must inform the County in writing of any program income generated
24 by the expenditure of CDBG funds. Any program income generated as a result of the Project must
25 be paid to the County. For purposes of this Agreement, program income is defined as proceeds
26 from the disposition of CDBG-acquired real property, and principal and interest on CDBG loans. If
27 the City contributed financially to the improvement Project, the City may retain a share of the
28 program income in proportion to the City's contribution to the Project, after the City has provided a

1 written accounting acceptable to the County.

2 S. The City must obtain prior written approval from the County before making
3 any modification or change in the use of any real property improved, in whole or in part, using
4 CDBG funds in excess of \$25,000. The City shall provide affected citizens with notice of, and
5 opportunity to comment on, any proposed change to the use of real property improved with CDBG
6 funds. If any real property improved with CDBG funds is sold and/or is utilized by the City for a use
7 which does not qualify under the CDBG Program, the City shall reimburse the County in an amount
8 equal to the current fair market value for the property, less any proportional share thereof
9 attributable to expenditures of non-CDBG funds. These requirements shall continue in effect for
10 five years after the Project is completed in HUD's Integrated Disbursement and Information System
11 (IDIS). In the event the CDBG program is closed out, the requirements of this Section shall remain
12 in effect for activities or property funded with CDBG funds, unless action is taken by the Federal
13 government to relieve the City of these obligations.

14 T. The City acknowledges that the County may periodically inspect the Project
15 to ensure the property is being used as described in this Agreement. The City agrees to provide
16 any necessary information to the County to carry out such inspections. Furthermore, the City
17 agrees to take corrective action if the County determines that modifications to the use and location
18 of the Project have resulted in a violation of the Federal CDBG regulations.

19 IV. CONFORMANCE WITH APPLICABLE LAWS AND REGULATIONS

20 A. The City shall, and shall cause its consultants, contractors, and
21 subcontractors to, comply with all applicable State and Federal laws and regulations governing the
22 Project.

23 B. Whenever the City uses the services of a contractor, the City shall require
24 that the contractor comply with all Federal, State and local laws, ordinances, regulations, and
25 Fresno County Charter provisions applicable in the performance of their work.

26 C. This Project is subject to the requirements of Section 3 of the Housing and
27 Urban Development Act of 1968, as amended, 12 U.S.C. 1701(u). Accordingly, the City shall
28 require the prime contractor to complete and submit documentation prior to award of the

1 construction contract, and upon Project completion, that compliance with the Section 3 clause has
2 been met.

3 D. Because the City is receiving at least \$100,000 for this Project from the
4 County's CDBG Program under this Agreement, the City shall complete and submit to the County
5 Community Development Division a "Certification of Payments to Influence Federal Transactions"
6 form and a "Standard Form LLL - Disclosure of Lobbying Activities" form. Likewise, before the City
7 awards a contract using at least \$100,000 of such CDBG funds, the City shall require the
8 consultant and/or contractor and all their sub-consultants and/or subcontractors to complete and
9 submit these two (2) forms described herein to both the City and the County.

10 V. PAYMENT FOR THE PROJECT

11 A. At monthly intervals, the City shall submit a written request to the County for
12 payment of specified costs incurred in the performance of this Agreement. The request for payment
13 shall be accompanied by a written certification from the City that the request for payment is
14 consistent with the amount of work that has been completed, and that said work is in accordance
15 with the contract documents and this Agreement. The request for payment shall also be
16 accompanied by documentation acceptable to the County, such as invoices or vouchers for
17 services or materials purchased, contractor's costs, or other costs chargeable to the Project. After
18 appropriate review and inspection, the County shall make payment from CDBG funds provided in
19 this Agreement for all eligible costs specified herein up to the maximum amount payable under
20 Section I.

21 B. Any savings realized in the final cost of the Project, due to Project cost
22 and/or scope of work reductions, liquidated damages, or any other reason, shall be used to reduce
23 the amount of this Project paid for with CDBG funds, and shall be credited to the City's CDBG
24 allocation. If the City is required to provide any funds toward the Project, any cost savings shall be
25 first used to reimburse the City for its contribution in excess of the total amount provided by this
26 Agreement.

27 C. Payment for advertising and award shall be based on the actual costs of
28 printing and noticing.

1 D. The County will not be bound by any agreement between the City and its
2 agents.

3 E. Upon the completion of the Project, the City shall submit to the County
4 Community Development Division a written request for final payment of costs which shall provide
5 a detailed description of the Project pay items and costs. The County shall not be obligated to
6 make any payments under this Agreement if the request for payment is submitted by the City more
7 than sixty (60) days after the Notice of Completion has been filed with the County Recorder's
8 Office. An extension to the sixty (60) day period may be granted by the Director prior to the deadline
9 if the City can demonstrate just cause for the delay.

10 F. The County may withhold reimbursement to the City until a final POM,
11 recorded NOC, and written summary of all Project work completed with CDBG and other funds,
12 and evidence of compliance with the Section 3 clause, as specified in Sections III-O and IV-C,
13 have been submitted to the County.

14 G. All requests for payment and supporting documentation shall be sent to:

21 H. The City shall establish accounting and bookkeeping procedures in
22 accordance with standard accounting and bookkeeping practices, including, but not limited to,
23 employee time cards, payrolls, and other records of all transactions to be paid with CDBG funds
24 in accordance with the performance of this Agreement. All records and accounts shall be available
25 for inspection by the County, the State of California, if applicable, the Comptroller General of the
26 United States, and HUD or any of their duly authorized representatives, at all reasonable times,
27 for a period of at least five (5) years following final payment under this Agreement, or the closure
28 of all other pending matters, whichever is later. The City shall certify accounts when required or
requested by the County.

I. The City, as a sub-recipient of Federal financial assistance, is required to

1 comply with the provisions of the Single Audit Act of 1984 (31 U.S.C. Sections 7501 et seq.), as
2 amended. Whenever the City expends and/or receives CDBG funds from the County for the
3 Project, a copy of any audit performed by the City in accordance with said Act shall be forwarded
4 to the County Community Development Grants Program Manager within nine (9) months of the
5 end of any City fiscal year in which funds were expended and/or received for the Project. Failure
6 to perform the requisite audit functions as required by this paragraph may result in the County
7 performing any necessary audit tasks, or, at the County's option, the County contracting with a
8 public accountant to perform the audit. All audit costs related to the City's failure to perform the
9 requisite audit are the sole responsibility of the City, and such audit work costs incurred by the
10 County shall be billed to the City, as determined by County's Auditor-Controller/Treasurer-Tax
11 Collector. In the event the City is only required to perform an audit under the provisions of the Act
12 because the City is receiving CDBG funds, the County may perform, or cause to be performed,
13 the required audit, to determine whether funds provided through this Agreement have been
14 expended in accordance with applicable laws and regulations. Any audit-related costs incurred by
15 the County under this provision shall be charged to the County CDBG Program. The City agrees
16 to take prompt and appropriate corrective action on any instance of material non-compliance with
17 applicable laws and regulations.

18 J. The City shall send a copy of the audit to:

25 VI. INDEMNIFICATION

26 Each party to this Agreement shall indemnify, defend, and hold harmless the other
27 party, its officers, agents, employees and representatives, from any and all loss, liability, costs,
28 expenses and damage to persons or property, and from any and all claims, demands and actions
in law or equity (including attorney's fees and legal expenses) arising or alleged to have arisen
directly from any wrongful acts caused by its respective activities pursuant to this Agreement. The

1 provisions of this Section VI shall survive the termination of this Agreement.

2 VII. TIME OF PERFORMANCE

3 A. The following schedule shall commence on the date this Agreement is
4 executed by the County.

5 1. Complete Design Engineering and Submit to the County for Review
6 – March 6, 2020.

7 2. Complete County Review and Approval of Plans – June 12, 2020.

8 3. Begin Advertising for Bids – July 1, 2020.

9 4. Award Contract – September 1, 2020.

10 B. The Project shall be completed, and Notice of Completion shall be filed with
11 the Fresno County Recorder's Office, no later than February 19, 2021.

12 C. The final POM Report, written summary of all work completed,
13 documentation demonstrating compliance with the Section 3 clause, and request for final payment
14 shall be submitted to the County no later than April 16, 2021.

15 D. The City shall give immediate written notification to the County Community
16 Development Division of any events that occur which may affect the above time schedule and
17 completion date and the time schedule specified in the contract documents, or any event that may
18 have significant impact upon the Project or affect the attainment of the Project's objectives. The
19 Director is authorized to make adjustments in the above schedule if, in the Director's judgment,
20 any delay is beyond the control of the parties involved.

21 E. Time is of the essence in the City's performance of this Agreement.

22 VIII. BREACH OF AGREEMENT

23 In the event the City fails to comply with any of the terms of this Agreement, the
24 County may, at its option, deem the City's failure a material breach of this Agreement, and utilize
25 any of the remedies set forth in 24 CFR 85.43, or any other remedies that the County deems
26 appropriate. Should the County deem a breach of this Agreement material, the County shall
27 immediately be relieved of its obligations to make further payment as provided herein. Termination
28 of this Agreement due to breach shall not, in any way whatsoever, limit the rights of the County in

1 seeking any other legal relief in a court of law or equity, including the recovery of damages. In
2 addition to the Agreement being terminated by the County in accordance with a material breach of
3 this Agreement by the City, this Agreement may also be terminated for convenience by the County
4 in accordance with 24 CFR 85.44.

5 IX. TERMINATION OF PROJECT

6 A. If the City decides to cancel the Project covered by this Agreement, the City
7 shall submit a request in writing to the County Department of Public Works and Planning,
8 Community Development Division explaining just cause for the request. The Director is authorized
9 to approve such a request if, in the Director's judgment, there is just cause for the Project's
10 cancellation.

11 B. If the City's request to cancel the Project covered by this Agreement is
12 approved by the Director, the City shall promptly return to the County all payments of specified
13 costs incurred in the performance of the Agreement to date.

14 C. If the Director approves the City's request to cancel the Project, any
15 unexpended CDBG funds budgeted to the Project under this Agreement may be credited to the
16 City's CDBG allocation, as appropriate.

17 X. VENUE; GOVERNING LAW

18 Venue for any action arising out of or relating to this Agreement shall be only in
19 Fresno County, California. The rights and obligations of the parties, and all interpretation and
20 performance of this Agreement shall be governed in all respects by the laws of the State of
21 California.

22 XI. ENTIRE AGREEMENT

23 This Agreement constitutes the entire agreement between the City and the County
24 with respect to the subject matter hereof, and supersedes all previous negotiations, proposals,
25 commitments, writings, advertisements, publications, and understandings of any nature
26 whatsoever unless expressly included in this Agreement.
